- To encourage greater collaborators and networking among construction industry players

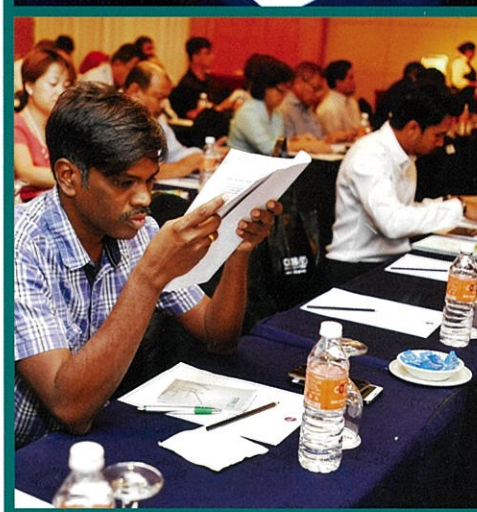
