## LEBIH 3,000 DAFTAR UJIAN SARINGAN COVID-19 DI DUN BUKIT ANTARABANGSA DAN DUN HULU KELANG



**PROGRAM** Saringan Covid-19 Komuniti porcuma di bawah kerajaan Negeri Selangor yang berlangsung di dua Dewan Undangan Negeri (DUN) di Gombak pada 18 Mei 2021 menerima lebih 3,000 penyertaan. Dato' Seri Amirudin Shari, Menteri Besar Selangor telah hadir membuat lawatan ke program Saringan Komuniti di Dewan Dato' Ahmad Razali, Ampang Jaya dan seterusnya ke Dewan Serbaguna MPAJ AU2. ## *More Than 3,000 Registered for the Free Covid-19 SWAB Test at DUN Bukit Antarabangsa and DUN Hulu Kelang*

**THE** free Covid-19 swab test program under Selangor state government that were held at two 'Dewan Undangan Negeri' (DUN) in Gombak on 18 May 2021 received more than 3,000 participations. A total of 1,100 people registered through the SELangkah application at Dewan Dato' Ahmad Razali while 2,000 people registered at the Dewan MPAJ AU2. This indicates a high awareness in the

community to make screening. Dato' Seri Amirudin Shari, Chief Minister of Selangor paid a visit to the community screening program at Dewan Dato' Ahmad Razali, Ampang Jaya and Dewan MPAJ AU2. The State Government has allocated RM6 million to continue the free Covid-19 Community Screening throughout the state to curb the pandemic. The screening process used rapid antigen test

kit (RTK-Ag) that allows Covid-19 infection to be detected in less than 30 minutes. Also present were YB, Puan Dr Siti Mariah binti Mahmud, Selangor State Exco for Public Health, Unity and Women & Family Development; YB Tn. Saari bin Sungib, Hulu Kelang Assemblyman; and Tn Johari bin Atli, Director of Legal Department (executing the work of MPAJ's Secretary).

## PROGRAM MOBILISASI VAKSIN KOMUNITI (MOVAK) DIPERLUAS KEPADA KOMUNITI PENIAGA KECIL

Selangor dipilih sebagai destinasi pertama kerana mempunyai jumlah jangkitan kes yang tertinggi pada ketika itu. Projek nirlis MOVAK disempurnakan pada 6 Julai 2021 oleh Menteri Perumahan dan Kerajaan Tempatan, Datuk Zuraida Kamaruddin, membabitkan seramai 504 penjaja daripada 8,812 penjaja yang berafaaf di bawah Majlis Perbandaran Ampang Jaya (MPAJ). Program yang berlangsung di Dewan MPAJ Dato' Ahmad Razali, Ampang itu membabitkan seramai 51 petugas dan sukarelawan iaitu 18 petugas kesihatan dan 33 lagi adalah octugas bukan kesihatan. Ia mempunyai empat komponen yang terdiri daripada Unit Panggilan, Unit Mobilisasi, Unit Jangkauan Komuniti dan Unit PPV Bergerak. Turut hadir adalah YB Datuk Halimah binti Mohamed Sadique, Menteri Perpaduan Negara diiringi oleh Tn. Mohd Fauzi bin Mohd Yatim, Yang Dipertua MPAJ.



### Community Vaccine Mobilization Program (MOVAK) Extended to Small Business Community

**THE** Community Vaccine Mobilization Program (MOVAK) under the Ministry of Housing and Local Government (KPKT) has been extended to small business community. The program in collaboration with the Ministry of National Unity and the Ministry of Energy, Science, Technology and Innovation (MNSTI)

is extended to night market hawkers, farmers' markets, morning markets, wet markets and other traders who fall into the hawkor category and registered with the local authority (MPJ).

Selangor was chosen as the first destination because it had the highest number of case infections at that time. The MOVAK pilot project was officiated on 6 July 2021 by the Minister of Housing and Local Government, Datuk Zuraida Kamaruddin, involving a total of 504 hawkers out of 8,812 hawkers registered under Ampang Jaya Municipal Council (MPAJ). The program took place at Dewan MPAJ Dato' Ahmad Razali, Ampang involving 51 officers and volunteers that were 18 health workers and 33 non-health workers. It has four components consisting of Call Unit, Mobilization Unit, Community Outreach Unit and Mobile PPV Unit. Also present were YB Datuk Halimah binti Mohamed Sadique, National Unity Minister accompanied by Tn. Mohd Fauzi bin Mohd Yatim, MPAJ's President.

### **Site Visit on Open Burning Complaint**

**DID** you know that open burning is wrong under the laws of nature and human law? Nature will experience air pollution while under UUK Garbage Collection, Disposal and Disposal (MPAJ) 2007, UUK 16: no one can burn or cause to be burned incinerators, garbage, or waste except in the manner and place approved by the local authority and the Director General of Environmental Department. The responsible party may be tried not more than RM2,000.00 or imprisoned not more than one year or both.

Based on complaints received, a site visit was held on 23 July 2021 at Taman Bukit Melawati, Taman Wanisan, Empangan Klang Gates and a piece of land near to Masjid Al Mardhiah, Taman Melawati. MPAJ's Health and Environment Department was present together with JKP zone 1 councilor, Tuan Mohamed Radziff bin Hasan; representative from Gombak Land and District Office; and residents to identify the exact location of the open burning. The continuous open burning has caused nuisance to the nearby residents. Ongoing monitoring will be implemented to address such complaints.

Pencemaran dikesan pada jam 11.10 pagi itu menjadikan bekalan air di 172 kawasan di Petaling, manakala Hulu Langat (54), Sepang (194), Putrajaya (23) dan Kuala Langat (20). Mendengar rintihan dan keluhan penduduk Ampang Jaya yang terputus bekalan air, kakitangan MPAJ telah menggerakkan usaha menghantar bekalan air bersih ke kawasan-kawasan yang terjejas. ## *463 Areas In Selangor, Putrajaya Affected by Water Disruption*

**463** areas in five districts in Selangor experienced unscheduled water supply disruptions after Sungai Semenyih's water treatment plant been discontinued due to odor pollution detected at Jenderam Hilir's raw water pump station on 31 August 2021. The pollution was detected at 11.10 am and affected water supply in 172 areas in Petaling, 54 in Hulu Langat, 194 in Sepang, 23 in Putrajaya and 20 in Kuala Langat. Hearing the grievances and complaints of people in Ampang Jaya who faced water disruption, MPAJ staffs helped to send clean water supply to the affected areas. MPAJ used tanker trucks to deliver clean water supply.





## **MPAJ TURUN PADANG BAGI PENYELESAIAN ADUAN DI PANGSAPURI ONE JELATEK DAN SERI MAYA**

complaint, MPAJ made a site visit to One Jelatek Condominium and Seni Maya Condominium to solve a few issues regards to the complaint on 14 August 2021. Present were Iuan Johari bin Atli, Director of Legal Department (executing the work of MPAJ's Secretary) with a few directors and officials from MPAJ to discuss a strategic holistic solution to the complaint.

**Worldwide Holdings Berhad** (**Worldwide Holdings**) has signed an agreement with five local authorities (PBT) in Selangor to implement the development of an integrated solid waste management centre (ISWMC). The five local councils are Shah Alam City Council (MBSA), Petaling Jaya City Council (MBPJ), Subang Jaya City Council (MBSJ), Ampang Jaya Municipal Council (MPAJ) and Kuala Selangor Municipal Council (MPKS). The agreement ceremony was done virtually and signed by Tuan Mohd Fauzi bin Mohd Yatim, the President of MPAJ, and witnessed by YAB Dato' Seri Amiruddin bin Shaari, Selangor Chief Minister on 19 August 2021.

The implementation of 'Waste to Energy' (WTE) technology is also in line with the government's goal of achieving renewable energy generation capacity by 20 percent by 2025.
