**Residents: Move illegal traders to ensure EKVE built on time** *TS 7/11/17 NS 04*

TRADERS in Hulu Kelang, Kuala Lumpur, whose shops made way for the East Klang Valley Expressway (EKVE) project, are now operating illegally in protest at an intersection near the project site.

This is causing a delay in the highway project and adding to the unhappiness of Ukay Perdana and Bukit Antarabangsa residents who now have to contend with poor traffic flow in the area since construction started.

The residents are calling on the authorities to step in and remove the makeshift canopies put up by some of the traders at an intersection of Jalan Ukay Perdana.

It was reported earlier that 39 traders were relocated to the site temporarily after their shops were demolished on Aug 16, and were later given an alternative site in Keramat AU3.

Some of them moved to the alternative site but a few remained at the temporary location.

Affected residents had a meeting and called for Ampang Jaya Municipal Council (MPAJ) to address the problem and ensure that the highway project proceeded without delay, which would prolong the traffic congestion there.

"The trading site was supposed to be a temporary solution for two to three days until they moved to their new location," said Ukay Perdana Joint Assembly Residents Associations vice-chairman Murza Murad.

"But they have continued trading there for a few months now, so we residents are asking for MPAJ to remove the obstacles immediately.

Murza said that when the residents asked EKVE concessionaire Ahmad Zaki Resources Berhad (AZRB) about the delay, the company said work could not proceed while traders were still at the intersection.

All 39 traders were offered a token sum of RM8,000 by AZRB, which none of the traders accepted.

Bukit Antarabangsa resident Al Bakri Ali said that although sympathetic to the traders' plight, residents did not want unnecessary delays affecting the project.

"The canopies are interfering with the implementation of road plans for the project, the main road is used as the only exit for us and several other neighbourhoods in the area," he added.

AMPANG – Majlis Perbandaran Ampang Jaya giat melaksanakan tangkapan anjing liar di sekitar kawasan pentadbiran pihak berkuasa tempatan itu.

Yang Dipertua MPAJ, Abd Hamid Hussain berkata, pihaknya sedia maklum berhubung laporan aduan daripada masyarakat mengenai isu ini.

“Kita juga berhadapan dengan masalah untuk menangkap anjing liar ini kerana operasi penangkapan di Ampang Jaya kini dilaksanakan sebuah syarikat swasta yang dilantik,” katanya.

Menurutnya, MPAJ tidak ada masalah untuk bekerjasama dengan mana-mana agensi untuk melaksanakan operasi penangkapan, menguruskan atau melupuskan anjing liar.

“Kita amat mengalu-alukan syarikat swasta atau Persatuan Pencegahan Penganiayaan Haiwan (SPCA) menjalin kerjasama bersama MPAJ, saya mahu isu ini diatasi segera,” katanya.

Katanya, syarikat atau agensi berkenaan harus mempunyai doktor veterinar jika mahu melupuskan anjing tersebut.
