MPAJ raids 25 premises and seizes goods

AMPANG Jaya Municipal Council (MPAJ) raided 25 premises for defaulting on paying their assessment tax.

It also seized electrical items at those premises to be auctioned off to cover the outstanding amount owed to the council.

MPAJ president Datuk Abdul Hamid Hussain said the owners of the residential units and commercial lots ignored the assessment bills and warrants issued to them.

"The standard operating procedure is to issue them a warrant if

they fail to pay their assessment tax.

"If they continue to ignore the notices issued, we will seize their moveable objects.

"To-date, we have auctioned off the objects for RM6,000, but that alone could not cover their arrears," he said, adding that MPAJ had conducted 10 raids this year.

From January to September, 3,598 out of 5,933 assessment bills issued were not settled.

Together with the unpaid warrants, the council had an outstanding amount of more than RM14mil this year.

MPAJ recorded RM44,216,238 in

arrears from unpaid assessment tax and warrants since 2017.

Abdul Hamid cautioned defaulters that the council would take legal action against property owners if the outstanding assessment exceeded RM10,000.

"Another problem we face is vacant properties that defaulted on their payment. We could not seize any item from them during the operations.

"We will issue a letter of demand to the property owners," he said in a press conference after the council's full board meeting.

MPAJ will also monitor closely the slope at Kampung Bukit Sungai

Puteh following soil erosion on Oct 12 as well as facilitate the construction of the Langat 2 water retention pond.

"We have also sent a notice to the Forestry Department to monitor the slope that is part of the Sungai Puteh forest reserve," he said.

This month, MPAJ received several awards, including the Low Carbon City Award.

MPAJ Building and Architecture Department and Lex Legis group from the Law Department were awarded the International Innovation Award during the Selangor Research, Development and Innovation Expo 2019.
