FOLLOWING public outcry over the state of dirty food premises, *StarMetro* speaks to local authorities in Putrajaya and Sepang to find out how they are handling the situation.

Putrajaya

Though Putrajaya Corporation's (PPj) stand as the local authority is to practise soft diplomacy on food stall operators by instilling awareness before resorting to enforcement, it is also realistic about their attitude on the ground.

Throughout their course of duty, officers have seen food handlers kneading *roti canai* dough with their feet and washing raw meat in toilets, and even found rat droppings in bags of dried shrimp.

"In such cases, the premises will be shut down," said PPj Environmental Health officer Azman Hassan.

"The hard truth is, some food operators don't have the right attitude for the business. They are only interested in profits," said PPj City Services vice-president Datuk Azizi Ahmad Termizi.

"The most effective way to put these errant operators out of business, is for the public to boycott these restaurants," he said.

Unfortunately, some do not seem to mind frequenting dirty eateries, Azizi said, citing as example a popular *nasi kandar* joint in a northern state where rats were seen scurrying around but the eatery continued to see high number of customers.

In Putrajaya, where food waste enjoys a new lease of life as plant compost, the health and environment department overlooks the hygiene of 360 eateries operating within the administrative capital.

There are only two categories given to eateries operating in Putrajaya - Grade A and Grade B.

If a premises falls into the Grade C category, it will be asked to shut down for two weeks.

Within this time frame, the restaurant owner is expected to clean up the premises, send its workers for food handling courses or medical treatment and correct its food handling practices.

"Frequency of checks is every nine months for Grade A restaurants and six, for those in the B category."

"During this time, the workers are also checked for typhoid vaccinations."

"Should PPj receive complaints from the public or requests from the eatery owner then inspections will be carried out sooner," said Azizi.

On whether the frequency of these checks will be increased following the spate of public complaints on dirty eateries, Azizi said this would be possible with the addition of manpower, which PPj was looking into.

From 2016 up to April 2018, the PPj Health Department had shut down 32 premises.

However, none of these premises had its licence suspended.

To encourage eatery operators to improve their hygiene standards, those in the Grade A category are given free publicity on PPj's Facebook page, which has close to 270,000 followers.

During the fasting month, PPj's

Environmental Health division set up a booth at the site of the Ramadan bazaar in Putrajaya to ensure food traders toed the line when it came to food handling practices.

"Inspections were carried out every day and compounds were issued for each offence," said Azman.

Sepang

Up to May this year, Sepang Municipal Council (MPSepang) closed down 36 of 2,000 eateries within its jurisdiction, said MPSepang Public Relations and Corporate Unit head Afra' Fardillah Zai Mustapar.

Quoting MPSepang Health Department director Kuzaini Hamidon, Afra' said a majority of the offences were dirty kitchens, cockroaches, rat droppings and shoddy maintenance.

It has also come to the council's attention that a majority of the foreign workers hired by eateries were unfamiliar with local hygiene standards.

As they do not understand the local language, it is difficult for officers to explain the offences they have committed.

"There is a need to address this because the food handling courses, which are compulsory for those working in restaurants to attend, are held in Bahasa Malaysia.

"If the course is being attended by restaurant workers who are from Myanmar, how are they to follow the lesson?" asked Kuzaini.

He has brought the matter up with the Health Ministry, proposing that they come up with educational pamphlets in multiple languages and include more images and graphics to get the message across.

On the frequency of checks, Afra said Grade A restaurants are checked twice a year and those who fall in the B category

are inspected thrice.

During the inspections, the council also conducts checks on typhoid vaccinations, grease traps, toilets and storage areas.

Restaurant workers who have not been vaccinated will be given 14 days to do so, failing which a compound of no more than RM1,000 can be issued by the local authority.

MPSepang's Health Department has 10 officers working in pairs to go on inspection rounds day and night.

The council, however, has yet to comment on its next course of action on a recent complaint pertaining to dirty backlanes in Jalan GC 4, 7 and 5 in Cyberjaya.

A visit made by *StarMetro* saw a food operator washing dishes at the rubbish-strewn back lane.

Kitchen sinks, though equipped with grease traps, were connected to pipes discharging sullage directly into drains.

Repeated attempts to contact MPSepang's Town Services Unit head Norrehan Amat Kasman and the Public Relation And Corporate Unit for comment on this matter were unsuccessful.

StarMetro would like to urge readers to alert us on dirty restaurants and we, on our part, will alert the authorities to act against these irresponsible operators.

Bayar segera, jangan tangguh-tangguh

AMPANG - Majlis Perbandaran Ampang Jaya (MPAJ) menggesa pemilik premis (kawasan kediaman, bangunan perniagaan, bangunan industri dan kawasan tanah lapang/kosong) di dalam kawasan MPAJ agar membuat bayaran cukai taksiran segera tanpa sebarang penangguhan.

Yang Dipertua MPAJ, Abd Hamid Hussain berkata, tahun ini sebanyak 241,572 bil telah diedarkan dengan nilai RM46.06 juta bagi tempoh setengah tahun pertama dan setengah tahun kedua di mana akhir bayaran adalah pada 31 Ogos ini.

"Pengecualian hanya melibatkan 51,287 unit sahaja dengan nilai bil bagi tahun ini adalah RM9.87 juta. Namun pemilik rumah kos rendah dan kampung masih perlu menjelaskan tunggakan cukai taksiran bagi tahun 2015 dan tahun sebelumnya. Adalah diingatkan pengecualian ini adalah hanya untuk tahun 2016 hingga tahun ini sahaja," katanya.

Beliau berkata, MPAJ turut melaksanakan operasi kutipan selepas penghantaran notis E dan waran April 2018 telah dilaksanakan di beberapa kawasan.

Abd Hamid berkata, penduduk adalah diingatkan agar mengambil tanggungjawab menyelesaikan tunggakan cukai taksiran, walaupun premis dibiarkan kosong.

"Sekiranya premis itu disewa, penyewa premis juga perlu maklum bahawa sekiranya pemilik tidak membuat bayaran cukai taksiran di bawah Seksyen 151 (5) Akta Kerajaan Tempatan 1976 (Akta 171) bayaran sewa rumah boleh ditolak dengan menyerahkan resit bayaran cukai taksiran yang telah dijelaskan oleh penyewa," katanya.
