Amirudin: S'gor govt committed to serving the people

KLANG: The Selangor government will ensure that the mandate given to it by the people in the 2018 general election is upheld, says Mentri Besar Datuk Seri Amirudin Shari. He said the state government was

committed to serving the people of Selangor.

"This administration vows to continue to respect the mandate of the people to accomplish the agendas that are beneficial to the state and the people of Selangor," he said in a statement yesterday.

It was issued after Amirudin

attended an audience with Selangor Ruler Sultan Sharafuddin Idris Shah at Istana Bukit Kayangan in Shah Alam

He was accompanied by Selangor DAP chairman Gobind Singh Deo and state Parti Amanah Negara chief Izham Hashim during the meeting with the Ruler.

The three leaders briefed Sultan

Sharafuddin on the state's position amidst the current developments in the national political situation.

Amirudin said the Sultan was satisfied with the explanations given.

He said he also held a meeting

earlier with the state's component party chiefs, including Selangor Parti Pribumi Bersatu Malaysia (Bersatu) head Datuk Abdul Rashid Asari.

It is believed that Amirudin want-

ed Abdul Rashid to remain in the state executive council pending the outcome of the political situation at the federal level despite Bersatu no longer being part of Pakatan

> Abdul Rashid is the Selangor cul-ture, tourism, Malay customs and heritage committee chairman.

> However, the state's other Pakatan elected representatives were unhappy with this.

"We do not see the logic behind this arrangement. Abdul Rashid should leave the exco line up as his party is no longer part of Pakatan," said a PKR assemblyman.

He also said the group of PKR state assemblymen aligned to party president Datuk Seri Anwar Ibra-him strongly felt that Amirudin should be replaced as mentri besar. Amirudin is known to be an

Azmin protege and loyalist.

"We have been talking among ourselves that Amirudin should step down as the mentri besar because of his links with Azmin," said the assemblyman.

He said since Azmin was no longer a PKR member, it was diffi-cult for them to believe his follow-

ers would be loyal to the party.
"We will also be asking for Haniza Talha to be removed from the executive council line-up," said the assemblyman.

Haniza, the Lembah Jaya assemblyman, is the current Wanita PKR

chief and also a close ally of Azmin. Amirudin, however, told his party's Selangor elected representa-tives in an impromptu meeting that he was behind Anwar and Pakatan. Selangor has so far remained safe from any changes in the state administration, as the state Pakatan government is strong with 16 assemblymen from DAP, 20 from PKR and eight from Parti Amanah Negara.

Barisan Nasional has five assemblymen, PAS (one), Bersatu (five) and one independent assembly-man, which makes up 12 representatives in the state's 56-member legislative assembly.

Assessment rates expected to increase by 25% next year in line with upgrade

KUALA Langat District Council (MDKL) will officially become a municipality on March 1.

Its president Mohammad Zain A. Hamid said with the upgrade, the assessment rate would increase by 170%

Mohammad Zain said these figures were suggested by the Selangor Economic Planning Unit and would be reviewed.

director Lina Chan, who is acting
as the environmental consultant
for the paper mill.
She explained that the factory
would have control processes in
place to prevent and deal with pollution.
Following requests by council-

lors for the factory to issue envi-ronmental reports on a real-time basis, Chan said this would not be

possible as there were no local testing facilities.

However, she assured councillors that all environmental reports would be forwarded to the Department of Environment for monitoring purposes.

Mohammad Zain also warned

Chan that if the company did not comply with an earlier agreement to maintain an 80% local workforce, the council would revoke its business licence.

DBKL gets tough on defaulters

TENANTS of three units of the Intan Baiduri public housing project (PPR) in Kepong, Kuala Lumpur were slapped with a 14-day eviction notice starting Feb 24 for failing to settle their rental arrears.

Kuala Lumpur City Hall (DBKL) Community Development and Urban Wellbeing Department director Anwar Mohd Zain said a red notice would be served if the tenants fail to comply with the eviction notice.

"The red notice is the final notice and tenants must move out within seven days.

"However, if they pay up within the notice period, the eviction notice will be retracted," he said, adding that the errant tenants would need to pay at least 50% of the amount owed to DBKL.

Anwar said the tenants could go to Menara DBKL 3 in Jalan Raja Abdullah to settle the outstanding rental

The errant tenants racked up thousands of ringgit in arrears, with the highest amount standing at RM17,000.

Tenants of two units were served with the eviction notice by DBKL personnel in person, while another unit whose tenants were not home, had the notice affixed to the door.

PPR and public housing (PA) tenants in the city are required to pay a monthly rental of RM124 to DBKL.

On Feb 24, StarMetro reported that PPR Intan Baiduri was the first to be inspected by DBKL and that PPR Bukit Jalil would be the next to undergo the same process.

Anwar said the move was part of DBKL's efforts to recover the amount it is owed in rental from PPR and PA in the city.

"As of Dec 31, 2019, DBKL is owed RM22.862mil in arrears from tenants who are still occupying these units

ing these units.

"If we include previous tenants who had left, that figure would reach RM50mil," he said.
