**Peniaga Rambo rampas tapak niaga**

Pendapatan peniaga buah terjesas, Persatuan Penjaja dan Peniaga Kecil Taman Muda Selangor buat laporan polis

**AMPANG** - Persatuan Penjaja dan Peniaga Kecil Taman Muda Selangor menyelar tindakan seorang peniaga Rambo yang diperdayai merampas sebuah tapak perniagaan buah, di pasar pagi Taman Muda, di sini, 19 Disember lalu.

Pengerusinya, Chow Chee Keen berkata, pihaknya juga telah membuat laporan polis berhubung kejadian yang memimpin pemilik perniagaan yang juga sepasang suami isteri, Teoh Yoke Feng dan Lim Keen Wei.

"Pasangan ini telah berniaga di sini sejak 2015 untuk menyara empat anak dan ibu bapa mereka...sepanjang tempoh itu mereka turut meminta lesen perniagaan semestinya daripada Majlis Perbandaran Ampang Jaya (MPAJ), namun sehingga kini tidak diluluskan," katanya.

Chee Keen berkata, pihaknya difahamkan peniaga Rambo itu turut mendakwa telah mendapat lesen perniagaan semestinya daripada MPAJ.

"Peniaga berkenaan juga mahu berniaga di atas tapak perniagaan pasangan tersebut iaitu di tapak parkir, kami berasa curiga bagaimana peniaga Rambo ini mendapat kelulusan tersebut?," katanya pada sidang media, di sini, semalam.

Beliau berkata, pihak Persatuan Penjaja dan Peniaga Kecil Taman Muda Selangor tidak menerima kehadiran para peniaga dan peniaga Rambo.

"Mereka juga akan menjasakan pendapatan peniaga lain," katanya.

Dalam pada itu, Kean Wei berkata, keluarganya terpaksa meranggung kerugian

hampir RM3,000 apabila peniaga Rambo itu mengambil tapak perniagaannya.

"Saya tak dapat jalan-jalan perniagaan hampir seminggu, buah-buahan semuanya jadi busuk dan terpaksa dibuang, muju pihak persatuan bantu untuk dapatkan semula tapak perniagaan ini," katanya.

Sementara itu, Timbalan Ketua Biru Perkhidmatan dan Aduan Awam Gerakan, Ben Liew Pok Boon berkata, pihaknya dimaklumkan semua permohonan dan pembaharuan lesen perniagaan di Pasar Pagi Taman Muda perlu mendapat persetuju-

an daripada persatuan tersebut.

"Saya dimaklumkan para peniaga perlu mendapatkan surat sokongan daripada persatuan ini, sebelum borang itu dihantar ke MPAJ untuk proses selanjutnya," katanya kepada *Sinar Harian*.

Sementara itu, Pegawai Komunikasi Korporat MPAJ, Norhayati Ahmad berkata, pihaknya sedia maklum berhubung isu tersebut.

"Ia difahamkan masalah dalam pengurusan baru pasar tersebut, kami minta persatuan berkenan menyelesaikan masalah tersebut dengan kadar segera," katanya.

## Two Ampang politicians in verbal battle over local issues

IT HAS been an interesting year for Ampang as two politicians crossed swords over local issues.

Pandan MCA chief Datuk Leong Kok Wee and Teratai DAP assemblyman Tiew Way Keng are expected to contest the seat in the 14th general election.

One of the major issues they did not see eye to eye on was a commercial project in Taman Muda.

While Leong claimed the land was reserved for the relocation of Taman Muda market traders, Tiew and Ampang Jaya Municipal Council (MPAJ) said it was privately owned and earmarked for commercial use.

The project comprised a gymnasium, sports and shoe boutique, family entertainment hub and food court.

Taman Muda morning market traders objected as they feared they would have no place to go should the Selangor government relocate them from a temporary site along Jalan Bunga Tanjung 9.

Taman Muda Selangor Hawkers and Traders Association chairman Chow Chee Keen said the association had repeatedly objected to previous plans to develop the land for purposes other than a market.

Leong even lodged a report with the Malaysian Anti-Corruption

Commission over the project.

Both sides had called for multiple press conferences with little resolution in sight.

The duo also duelled over the relocation of SJKKC Choon Hwa from Hulu Langat to Taman Lembah Maju, Pandan.

The relocation plan was mooted when the enrolment dwindled to just 30 pupils.

The school board's application for the construction was rejected by MPAJ.

Leong, who is also the school's building committee vice-chairman, questioned the decision, saying all the procedures and documents were in order.

Tiew then held a press conference to explain why the application was rejected, but Leong

described the reasons given as minor and easily rectified.

The proposed plan to build a RM25mil convention centre on land earlier designated for a public park in Taman Melawati also received media coverage.

Other than a fasal court, the land houses the service centre of Gombak MP and Bukit Antarabangsa assemblyman Datuk

Seri Azmin Ali, who is also Selangor menteri besar.

Residents said MPAJ had cancelled the proposed park without notifying them.

MPAJ president Abdul Hamid Abdul Hussain defended the move, saying there was a need for a convention centre which would provide better facilities to the people.
